# RULES


## CHRISTMAS CRIB & TREE COMPETITION

COMMON JUDGING CRITERIA FOR CAKE BAKING INCLUDE:

1. Individual/Group of Maximum 4 Students

## 2. APPEARANCE:

- Visual Appeal, Including Overall Design, Creativity, and use of Color. - Precision in Decorating and Attention to Detail.

## 3. FLAVOR:

- Taste and Flavor Profile of the Cake. - Balancing of Ingredients for a Delightful Culinary Experience.

## 4. TEXTURE:

- Evaluation of the Cake's Texture, Considering Factors Like Moistness, Crumb Structure, and Mouthfeel.

## 5. TECHNIQUE:

- Display of Baking and Decorating Skills. - Precision In Executing Specific Techniques, Such as Frosting Application or Fondant Work.



## 6. CREATIVITY:

- Originality and Creativity in the Design and Concept of the Cake.
- Innovative use of Ingredients or Unique Thematic Elements.

## 7. THEME ADHERENCE:

- Alignment With Any Specified Theme or Category for The Competition.
- Consistency in Conveying The Intended Theme Through the Cake's Design.

## 8. CRAFTSMANSHIP:

- Overall Quality of craftsmanship, Including Smoothness of Frosting, Even Layers, and Structural Integrity.

## 9. BALANCE OF FLAVORS:

- Harmonious balance Between Different Flavors Present in the Cake.
- Complementary Flavors That Enhance The Overall Taste.



## **10. DIFFICULTY LEVEL:**

- Consideration of the Complexity of the Chosen Design or Techniques.
- Recognition of Challenging Elements Successfully Executed.

## **11. ALLERGEN MANAGEMENT:**

- The judges' overall Impression of the Cake, Taking into Account all Aspects.
- How well the Cake Stands out Among Other Entries

## **12. OVERALL IMPRESSION:**

- Adherence to guidelines Regarding Allergen Information and Labeling.
- Consideration for the Safety of Individuals with Allergies.

- Time - Max 5 Mins.
- Language - Malayalam or English
- Songs Should be Related to Christmas!
- Uniform - Dress Code is Appreciated
- Use of Karoke is Appreciated. Creativity, Rythm and Participation will be the Primary Criteria




