



RULE BOOK

Eligibility

Registration

1. Students can Register through the online link provided in the kerala Law Academy Web site.
2. Students shall provide the college ID card during registration procedure.
3. Registration fee Rs 250/-

Instructions

1. The event is individual competition
2. Its on the spot competition.
3. Content for News Reading will be provided by the organizers.
4. All the participants have to report the hall half an hour before the competition starts. Late comers are not permitted.
5. Each contestants will get 20 minutes time to prepare News bulletin with the support of News contents provided by the organizers.
6. Contestants have to prepare the News themselves with out any one support.
7. The contestants are free to add extra words to make the News more attractive.

- 8. The contestants are not permitted to use mobile phones while preparing the News or reading the News bulletin.**
- 9. The time duration of the news bulletin is 3 minutes.**
- 10. No prompter provided for News Reading.**
- 11. Participants shall bring writing pad and pen to prepare and draft news bulletin.**
- 12. The organizers reserve the complete right to modify the rules and regulations at any point of competition.**
- 13. In the case of dispute the organizing committee shall be final.**


